



- Currently, market access to this data has been limited to Google, Microsoft, and other major players. Our goal is to make it more accessible.
- We aim to provide this data to any company that can effectively and legally use this information because we strongly believe that it will improve the quality of the internet.

Minimal Required Data Fields:

- User location (country)
- Event timestamps

- Referral URL
- Target URL

How will this data be used?





Data collected from your products will be used in DATOS and world-known marketing companies' products, like - traffic insights analytics, competitive research, online market valuations and other.

The data that we collect will be fully anonymized. This means that it will be impossible for us to detect any individual users or access their personal data.
